

KAFB Installation Commander's Directive update – ICD #041: Effective Monday, November 16, 2020

In response to the New Mexico "Reset" to mitigate the recent surge in active COVID-19 cases, the installation will impose additional restrictions effective today, Nov. 16, 2020. The installation will regress to a modified Increment 2 plan (Increment 2 Plus), with significant changes highlighted below.

On Kirtland AFB, use of cloth face coverings are required at all times (indoor/outdoor). <u>Exceptions</u>: Individual workspace / residence areas exempt unless the six foot radius of social distancing cannot be achieved; when not possible while performing mission essential/critical tasks as approved by Unit Commander; when vigorously exercising outdoors alone, masks are not required.

PERSONNEL

Units are to reduce the on-base workforce to Increment 2-Plus levels and implement their athome workforce telecommute plan. Units may not to exceed 50% of their total workforce on base concurrently. Temporary mission-responsive personnel surges remain authorized.

PCS travel is no longer subject to the ROM 14-day self-quarantine if both the losing and gaining locations (state/territory/nation and installation) are on the official travel restrictions green location list. If coming from a red losing location, the member **IS** subject to the ROM 14-day self-quarantine.

VISITORS may consider the installation as their ROM location but must refrain from entering on-base facilities (with the exception of seeking medical care) during their ROM period. Sponsors and their family members should use precautions and are permitted to attend work and should only leave home for immediate needs (i.e. groceries, medical appointments, prescription pick-up, etc.).

UNIT picnics, potlucks or other self-serve catering events NOT authorized.

FACILITIES

CDC: Will maintain mission essential or return to work (no telework) support levels at least equivalent to current Increment 2-Plus workforce. On-base workforce will be given priority.

DFAC: Meal Card Holders **ONLY**; Take-out only.

On-base Food Services

Take-out only (no indoor/patio dining)
