



KAFB Phased Reopening updates:  
effective Friday, June 26, 2020

*All below are significant changes/updates*

### **Declaration of a Public Health Emergency renewed**

This declaration renewal will terminate on 31 July, 2020.

### **Personnel**

*Local Area Leave Policy* is rescinded and replaced by AF/A1 guidance (AF/A1 022030ZJun 20) *conditions-based phased approach to personnel movement and travel*. Each state, territory, host nation and military installation will be evaluated to determine if they are cleared for non-restrictive travel. ### **Official Travel (PCS/TDY)**

- a. No longer subject to the ROM 14-day self-quarantine if both the gaining and losing location (state/territory/nation and installation) are on the official travel restrictions green location list.
- b. If either gaining or losing location or installation are under restrictive travel an Exception to Policy (ETP) must be approved prior to movement.
- c. Waivers may be processed for mission essential, humanitarian, and hardship movements.
- d. If a member travels through a restricted travel area enroute and has prolonged exposure to that area (i.e. overnight, exposed to mass gatherings, etc.) the member is subject to ROM protocols.
- e. Air travel originating and ending in non-restrictive areas no longer require the 14-day self-quarantine and layovers at any location are acceptable *as long as the member remains in the airport terminal*.

### **Personal travel (Leave / Special Pass)**

- a. Squadron Commanders may approve travel out of the local area if both the to and from locations (state/territory/nation) are on the travel restrictions green location list.
- b. If originating or destination location is red in any category it is considered restrictive travel and requires an Exception to Policy.
- c. All approved personal travel requires supervisors to conduct a pre-departure briefing using the COVID-19 Risk Exposure Activity Worksheet.
- d. If a member travels through a restricted travel area enroute and has prolonged exposure to that area (i.e. overnight, exposed to mass gatherings, etc.) the member is subject to ROM Protocols.
- e. Air travel originating and ending in non-restrictive areas no longer require the 14-day self-quarantine and layovers at any location are acceptable *as long as the member remains in the airport terminal*.

**Visitors**

- a. Visitors arriving at KAFB (regardless of mode or purpose of travel) NO LONGER require the 14-day Restriction of Movement (ROM) period if the departure location is identified as a non-restrictive travel area.
- b. If a visitor travels through a restricted travel area enroute and has prolonged exposure to that area (i.e. overnight, exposed to mass gatherings, etc.) the visitor is subject to ROM Protocols.
- c. Air travel originating and ending in non-restrictive areas no longer require the 14-day self-quarantine and layovers at any location are acceptable *as long as the member remains in the airport terminal*.
- d. Visitors meeting these requirements may be sponsored on base (via pass at the VCC).  
Note: visitors are advised to be aware of state and local COVID-19 policies.
