## Restricted Report

*Does NOT start AFOSI investigation  
and  
Chain of command is NOT notified*

You can make a report to:

- SARC/FAP/DAVA
- Healthcare provider
- Trained victim advocate
- Mental Health

You are entitled to:

- Confidential reporting
- Your own free Victims' Counsel
- Legal advice regardless of your restricted/unrestricted decision
- Medical/Counseling services
- Protection of your rights



*Victims' Counsel have an independent chain of command. They are not influenced by the victim's or perpetrator's chain of command.*

Represents **you** and **you** alone

Provides **you** confidential advice

Protects **your** rights/interests

Advises **you** on the military justice legal process

Attends interviews with **you**

## Unrestricted Report

*Initiates investigation with AFOSI and  
Chain of command is notified*

You are entitled to:

- Your own free Air Force Victims' Counsel (VC) who will:
  - Protect your interests and rights in all interviews and court-martial proceedings
  - Appear with you in Court
  - Advocate for you
- Details about your case
- Medical/Counseling Services
