

#### KAFB Installation Commander's Directive update – ICD #042: Effective Monday, November 23, 2020

In response to the New Mexico "Reset" to mitigate the recent surge in active COVID-19 cases, the installation will impose additional restrictions <u>effective today</u>, Nov. 23, 2020; see below.

### Effective IMMEDIATELY, a 14-day stay-at-home order is in place for KAFB.

- This directive is mandatory for all 377 ABW military personnel; and highly advised for civilian employees, mission partners and dependents.
- Exceptions will be permitted for "life essential trips" to get groceries, supplies, medical care, restaurant meals and fuel.
- Stay-at-home does <u>NOT</u> mean personnel who are deemed necessary to be in the office need to stay at home. Commander's discretion authorizes those personnel to work in the office.
- Personnel may continue to exercise outdoors; however, a mask is required unless exercising vigorously <u>alone</u>.
- The installation will remain at Increment 2 Plus levels (50% of the workforce) and commanders are encouraged to maximize telework where possible. Temporary mission-responsive personnel surges remain authorized.

# VISITORS:

**MUST** ROM in the domicile of their sponsor (or lodging) during their ROM period.

# LEAVE/PERSONAL TRAVEL:

- Effective immediately, <u>ALL</u> persons that travel out of the State of New Mexico for leave or personal travel will undergo a 14-day ROM. Civilian employees are encouraged to telework during the ROM period when possible or work with your leadership team to determine the appropriate absentee/purpose code.
- The ROM <u>MUST</u> be in the domicile/yard of the domicile.
- Units may request an exception to policy (ETP) for new arrivals prior to the expiration of the 14-day ROM if deemed they are critical to the mission. All ETPs to curtail or forgo the 14-day ROM requirement must be approved by the first O6 or GS15 in the person's chain of command. A standard ETP template will be distributed and is available. All approved ETPs must be sent to the 377 ABW to fully assess the aggregated risk being assumed.

# **OFFICIAL TRAVEL:**

TDY travel is not subject to the ROM 14-day self-quarantine. Unit commanders will assess the risk for people who are TDY and to determine if a ROM should be enacted based on the conditions of each person.

### PCS:

If coming from a **RED** losing location, the member **IS** subject to the ROM 14-day selfquarantine.

• Units may request an exception to policy (ETP) for new arrivals prior to the expiration of the 14-day ROM if deemed they are critical to the mission. All ETPs to curtail or forgo the 14-day ROM requirement must be approved by the first O6 or GS15 in the person's chain of command. A standard ETP template will be distributed and is available. All approved ETPs must be sent to the 377 ABW to fully assess the aggregated risk being assumed.
